

# WOOLABALL BOOKING TERMS AND CONDITIONS AND OPERATING PRACTICES & AGREEMENT.

Definitions ;

**Woolaball:** Is the business trading name also referred to as THE SITE in this document

**Hull paintball & Hull paintball site** are our promotional, social network and advertising names

**Hullpaintball.co.uk** is our web site domain name and the name of our Facebook promotion pages

**Booking confirmation;** Booking information - acts as contract, receipt, invoice.

**Woolaball booking terms and agreement and operating practices** also referred to as the **agreement**

**Booking :** All persons/person who belong to your party including spectators/ non players– Your booking is also personalised/custom/bespoke and made to order specifically for you. Individual or group tickets can be purchased for the booking.

**Group booking:** Any booking comprised of over two players.

**Individual booking:** Booking for one person

**Tickets/packages:** are the same

**Play tickets:** You buy a play ticket that is applicable to the package you choose

**Pay at the gate:** Means make payment at the main site entrance gate or on site on the day of the booking

**Advanced booking& payment discount (ABAPD):** All our normal paintball packages are discounted from our normal retail price. Our ABAPD is an incentive offered to customers who opt to pre book , pre pay and honour the contract. The ABAPD discount is usually £5 off every solo ticket sold and £50 off every Group ticket sold ( group tickets are for up to 10 players). Customers who do not pre book and pre pay will not qualify for the ABAPD-however the decision to award the ABAPD is at the sole discretion of the game manager.

The ABAPD can also be removed for those bookings that only pay a deposit and opt to pay at the gate on the day

**You:** the organiser

**Organiser;** A mentality competent, responsible Adult Person over 18 years of age who completes this agreement and voluntarily agrees to comply 100 % with this agreement/ensure members of their booking fully comply to this agreement/the informed consent play agreement and also to their and supervise the members of their booking

**Adult supervisor;** Adult Person/s over 18 years of age who have been appointed by the organiser to supervise their booking.

**Booking Reservation Deposit payment ;** An agreed non-refundable sum of money is paid to confirm the date and details of the booking. This can be the full amount payable or an amount paid per person determined by THE SITE. ( a refundable paypal payment/deposit is by agreement )

Please note - that when customers hand over a deposit they have made a legally binding contract, it doesn't matter whether there is a written agreement or not, and you don't need to have signed anything for the law to take hold.

The basic rule is that a deposit acts as surety for you entering into the contract and effectively guarantees that you will fulfil your side of the bargain. **Therefore, if you change your mind and pull out of the deal the supplier is entitled to keep your deposit payment.**

**Confirmation contract;** The point at which you confirm you wish use the services of Woolaball by paying a reservation deposit or full payment.

**Individual solo packages/ Tickets;** Are pre purchased tickets for individuals that include pre purchase discount paintballs that also includes the game fee if applicable.

**Group packages/Tickets:** Are pre purchased tickets for groups that include pre purchase discount paintballs and free bonus/organiser incentive paintballs (if applicable) and also includes the game fees.

**Bonus Balls;** A free gratuity offered by THE SITE { subject to availability, THE SITE reserve the right to issue or refuse bonus balls and incentives at any time }

**Discount paintballs;** Paintballs that are charged at a lower price per 100 than the Top line Pay as U Go rate/ recommended retail price.

**Organiser incentive;** A form of free gratuity given to organisers on behalf of THE SITE – usually free paintballs ( subject to availability)

**Game fee:** Total fee charged individually or group that covers the cost for all play equipment, and in some cases free paintballs

**Force Majeure;** literally means "greater force". These clauses excuse a party from liability if some unforeseen event beyond the control of that party prevents it from performing its obligations under the contract. Typically, force majeure clauses cover natural disasters or other "Acts of God", war, or the failure of third parties--such as suppliers and subcontractors--to perform their obligations to the contracting party. Force Majeure now includes the covid-19 pandemic and all pandemics and viral outbreaks. It is important to remember that force majeure clauses are intended to excuse a party only if the failure to perform could not be avoided by the exercise of due care by that party.

**Cancellation;** Organisers are free to issue notice direct to the SITE of their intention to cancel their booking anytime. Cancellation means their booking or members of will be absent from the agreed confirmed day and time. Failure of players under the age of 18 years of age to present a fully completed informed parental consent form signed by a parent or legal guardian constitutes cancellation.

**No Show:** Players that have not issued a cancellation notice direct to the site or their booking organiser and simply have not turned up and are absent.

**Cancellation Policy explanation ;** THE SITE can only allocate places up to its maximum capacity. Eg THE SITE must prepare the site, buy paintballs for the numbers booked, if 30 people have booked then that is 30 guns that need to be serviced ,gassed up and prepared, 30 goggles to be cleaned ,30 pairs of body armour , overalls and protective snoods to be laundered and prepared. If only 12 people turn up that constitutes a gross waste of time, resources and capital outlay which affects our profitability. Buying paintballs we don't need soaks up our working capital; paintballs also have a limited shelf life.

Places are allocated on a first come first served basis. When customers book a game of paintball places are then specially reserved. Other potential customers may then be turned away.

Customers who cancel at short notice or who fail to turn up on the day or fail to arrive with signed informed parental consent forms means THE SITE has lost the opportunity to reallocate/ rebook those places. This results in lost business and revenue. 'One would not book and pay for a buffet for 20 persons and expect a refund because only 12 people turned up'

Cancellation of your booking usually prevents others from booking at a specific time on a specific date and is therefore subject to a recognised cancellation policy for leisure activity bookings, which is in line with Regulation 6 2(b) within the Consumer protection (Distance Selling) Regulations 2000 issued by the Office of Fair Trading. Contracts for the provision of accommodation, transport, catering or leisure services ( paintball ), where the supplier undertakes, when the contract is concluded, **to provide these services on a specific date or within a specific period**. This means that, once the booking is in place/ confirmed via payment, your right to cancel without penalty ends.

Customers who cancel their booking but wish to defer their confirmed booking to another date may do so at THE SITE's discretion and subject to availability (deferral is not guaranteed) . An administration re-booking charge applies.

**Game deferment** : We try to be fair as possible and will always endeavour to seek an amicable solution. If WE offer to defer your booking due to force majeure we will so at no additional charge. If YOU request a deferment of your original booking then an additional charge of £10 per player is required.

**Cooling off period;** Your booking is bespoke / personalised to your specifications. This means we do not have to offer a cooling off period. When you book a specific date and time it usually prevents others from booking at the same specific time on a specific date and is therefore subject to a recognised cancellation policy for sporting activity/leisure bookings, which is in line with within the Distance Selling Regulations issued by the Office of Fair Trading. This means that, once the booking has been confirmed your right to cancel without penalty ends: HOWEVER as a gesture of goodwill THE SITE does provide a limited cooling off period. This can range from a few hours to a few days dependant of the game day booked. No cooling off period is offered for games commencing the same day.

**Low turn out;** If only 40% of total number booked turn up. THE SITE also needs to remain in profit and therefore it is essential enough revenue is acquired to justify opening - we will not run at a loss.

I hope you understand this stance THE SITE must take concerning its cancellation policy.

We try to be fair and transparent at all times and we think our customer service is second to none.

**Additional payments;** All expenses incurred eg Game fees, basic deals, food, gloves, pyrotechnics etc any payment for equipment or services that is applicable to your booking

**Paintball account;** All expenses incurred by your booking whilst playing paintball

**Late arrival policy;** You will be informed of your start time. You need to arrive at the THE SITE gate at least 15 minutes prior to your start time. Our gates will open at the start time agreed, our gates will close when all players and non players have signed the entry agreement. If you are going to be late please inform THE SITE as soon as possible.

Unless your booking is an exclusive booking for your party, players from other bookings will be sharing your session. It would not be fair or ethical to keep bookings that have arrived on time waiting for late arrivals. If you are late the main gates will be closed, to gain entry please call 07974630094.

Late entry will be at the total discretion of THE SITE. If the Safety induction process has started and you are late and permitted to play an additional £20 safety induction charge is payable per booking/person. Late entry also constitutes voluntary cancellation and subsequent loss of deposit and fees for game packages. The session will not be extended due to late arrival.

**A Child** – is any human being under the age of 18 years of age.

**An Adult** – A person who is 18 years of age or older

**Full payment** – All expenses incurred - all fees for game packages including deposit.

**Payment** – deposit/game fee payments will paid via BAC, Credit/debit Card, paypal, cash on the day

**Payment request** – Is an SMS or email requesting payment for your booking

**Low impact paintball** - Spring loaded Splat Masters or similar gun that shoot Low impact paintballs up to 100+ feet, at a velocity of 110-140 feet per second. Low impact paintballs are .50 cal ,roughly half the size of regular paintballs. Although there is no age limit for low impact , low impact paintball guns are spring loaded pump action, children under 7 may not be able to pump prime the gun for loading.

**Medium impact paintball** - Semi automatic ( or pump action ) paintball gun that shoots .50 cal paintballs at approximately 280 feet per second using a gas propellant.

**Normal (high impact) Paintball** – Semi automatic ( or pump action ) paintball gun that shoots .68 cal paintballs at approximately 280 feet per second using a gas propellant.

**Breach of contract** – Basically means that one or more of the terms and conditions laid out in a contract has been broken. i.e non payment for a service or not paying on time. i.e failure to comply to the following terms and conditions of this contract may constitute a breach of contract.

**Upgrades-** This is when a customer expresses a wish or informs THE SITE they wish to upgrade to a bigger paintball deal. Package upgrades on the day are not usually permitted, however this at the game managers discretion.

## **I THE ORGANISER UNDERSTAND AND AGREE.....**

1. TO CHECK, DOUBLE CHECK AND TRIPLE CHECK HOW MANY PLAYERS HAVE 100 % CONFIRMED THEY WISH TO PARTICIPATE. THAT THEY UNDERSTAND ONCE YOUR BESPOKE/ PERSONALISED BOOKING HAS BEEN CONFIRMED VIA THE PAYMENT OF THE RESERVATION DEPOSIT, FULL PAYMENT IS PAYABLE.

2. ONCE YOU HAVE PAID YOUR RESERVATION DEPOSIT YOU HAVE ENTERED INTO A CONTRACT WITH THE SITE
3. YOU AGREE TO PAY THE FULL FINAL PAYMENT AGREED ON YOUR CONFIRMATION CONTRACT
4. IF FULL PAYMENT OF ANY GROUP PAINTBALL TICKETS/PACKAGES HAVE BEEN PURCHASED IN ADVANCE. IN THE EVENT OF NO SHOW PLAYERS THEN THE ORGANISER MAY USE ALL THE PAINTBALLS INCLUDED IN THE PACKAGE.
5. IF FULL PAYMENT OF ANY INDIVIDUAL PAINTBALL TICKETS HAVE BEEN PURCHASED IN ADVANCE THEN IN THE EVENT OF NO SHOW PLAYERS THE ORGANISER MAY USE THE REMAINING BALANCE OF ANY TICKET/PACKAGE PAYMENT MINUS £15 RESERVATION DEPOSIT PAYMENT PER PLAYER TO BUY ADDITIONAL PAINTBALLS AT THE PAY AS U GO RRP PRICE
6. OUR PREFERRED MINIMUM AGE TO PLAY LOW IMPACT PAINTBALL/SPECTATE IS AGE 7. FOR REGULAR PAINTBALL IT IS AGE 11. PLAYERS YOUNGER THAN 7 WILL ONLY BE PERMITTED TO PLAY WITH SPECIAL PERMISSION FROM THE SITE.
7. **MANDATORY:** ALL PERSONS COMING ONTO THE SITE – PLAYERS, NON PLAYERS MUST SIGN THE AN INFORMED CONSENT BEFORE PERMISSION TO ENTER IS GIVEN.
8. **MANDATORY:** ALL PLAYERS/SPECTATORS/NON PLAYERS MUST ATTEND THE SAFETY INDUCTION/AGREEMENT AND THEN SIGN THE DECLARATION THEY UNDERSTAND THE INDUCTION AND AGREEMENT. NO SIGN NO PLAY OR STAY
9. **MANDATORY:** THAT ALL PLAYERS/VISITORS UNDER THE AGE OF 18 YEARS WILL NOT BE PERMITTED ENTRY ONTO THE SITE WITHOUT A FULLY COMPLETED PARENTAL INFORMED CONSENT FORM SIGNED BY A PARENT OR LEGAL GUARDIAN AND COUNTERSIGNED BY THE ORGANISER
10. ALL CHILDREN, NON PLAYERS, ESPECIALLY UNDER THE AGE OF AGE 11 MUST BE CLOSELY SUPERVISED BY PARENTS, THE ADULT ORGANISER OR ORGANISERS APPOINTED ADULT CHILD SUPERVISORS.
11. CHILDREN MUST NEVER BE LEFT UNSUPERVISED.
12. CHILDREN OR BOOKINGS WHO DO NOT ARRIVE AT THE SITE WITH SIGNED PARENTAL INFORMED CONSENT FORMS WILL NOT BE PERMITTED ENTRY ONTO THE SITE- FURTHERMORE –THIS WILL ALSO CONSTITUTE AS CANCELLATION RESULTING IN FORFEIT OF DEPOSIT AND FEES PAID.
13. AS ORGANISER IT IS MY RESPONSIBILITY TO CHECK ALL PARENTAL CONSENT FORMS/COUNTER SIGN THEM AS CORRECT AND INFORM THE SITE GAME MANAGER AT THE MAIN GATE IF ANY PARENT HAS MADE AN ENTRY IN 'ADDITIONAL INFORMATION' ESPECIALLY IN RELATION TO ANY MEDICAL/BEHAVIORAL CONDITION.
14. NO PETS ARE PERMITTED ON SITE –UNLESS PERMISSION IS GRANTED BY THE SITE – ALL PETS MUST BE KEPT ON A LEAD AND UNDER CONTROL –THE SITE TAKES NO RESPONSIBILITY FOR THE SAFETY AND WELLBEING OF PETS OR AGGRESSIVE ACTIONS OF THEM-PLEASE DO NOT ARRIVE AT THE SITE AND EXPECT YOUR PET WILL BE PERMITTED ON SITE.
15. I UNDERSTAND MY BOOKING MUST BE ESCORTED ON AND OFF THE SITE BY A MARSHAL AND I MUST UNDER NO CIRCUMSTANCES PERMIT ANYONE IN MY BOOKING TO ENTER OR LEAVE THE SITE UNESCORTED.
16. THAT THE SITE GATES WILL BE LOCKED FOR THE DURATION OF MY BOOKING TO PREVENT UNAUTHORISED ENTRY AND EXIT FROM THE SITE.
17. A PAINTBALL SESSION/BOOKING CAN ONLY BE BOOKED AND CONFIRMED BY A RESPONSIBLE ADULT PERSON 18 YEARS OLD OR ABOVE.
18. I AGREE TO PAY A NON REFUNDABLE PAYMENT WHICH WILL ALSO ACT AS A RESERVATION DEPOSIT ( see definitions )
19. THE MINIMUM DEPOSIT PAYMENT IS £15 PER PLAYER
20. A PAYMENT REQUEST WILL BE SENT TO YOU VIA SMS OR EMAIL
21. PAYMENT OF RESERVATION DEPOSIT CONFIRMS MY BOOKING AND ALSO CONFIRMS I UNDERSTAND AND FULLY AGREE TO THE TERMS & CONDITIONS AND WORKING PRACTICES – IF YOU DON'T AGREE TO THE TERMS AND CONDITIONS THEN PLEASE DO NOT PAY THE DEPOSIT

46. EXTRA TEA TIME OR EVENING SESSION TIMES WILL BE BY ARRANGEMENT

51. FULL DAY SIX HOUR PAINTBALL SESSIONS MUST BE BOOKED AND CONFIRMED.
52. LOW IMPACT SPLATBALL IS A TWO HOUR SESSION UNLESS OTHERWISE AGREED AND CONFIRMED BY THE SITE.
53. ANY REMAINING BALANCE FOR THE BOOKING WILL BE PAID IN CASH OR BAC / BANK TRANSFER USUALLY BEFORE OR UPON ARRIVAL ON THE DAY – THE SITE WILL INFORM YOU WHEN TO MAKE PAYMENT. PAYMENT USING A CREDIT/DEBIT CARD OR PAYPAL IS BY PRIOR ARRANGEMENT ONLY. THE FOLLOWING CARDS ARE ACCEPTED. MASTER CARD – VISA – DEBIT CARDS.
54. PAYMENT VIA CHEQUE MUST BE AUTHOURISED BY THE SITE.

57. CHEQUE PAYMENTS MUST BE RECEIVED BY THE SITE AT LEAST 7 DAYS BEFORE THE BOOKING DATE
58. YOUR BOOKING WILL ONLY BE CONFIRMED WHEN THE CHEQUE CLEARS IN THE SITE'S BANK ACCOUNT
59. THE SITE RESERVE THE RIGHT TO CANCEL AT SHORT NOTICE DUE TO ACTS OF FORCE MAJEURE. MOST COMMON REASONS - DAMAGED OR UNSAFE PLAY ZONE DUE TO ACTIONS OF INTRUDERS/TRESPASSERS, ADMINISTRATION ERROR, EXCESSIVE BAD WEATHER, BODILY INJURY, ACCIDENT, ILLNESS,, STAFFING PROBLEMS, COVID-19 QUARANTINE OR ISOLATION OF SITE STAFF. THE SITE WILL OFFER AN ALTERNATIVE DATE FREE OF CHARGE. THE SITE WILL NOT BE RESPONSIBLE FOR REIMBURSING THE ORGANISER OR ANY MEMBER OF THE BOOKING FOR ANY ADDITIONAL COSTS DUE TO FORCE MAJEURE.
60. THE SITE ALSO RESERVE THE RIGHT TO CANCEL YOUR BOOKING DUE TO NON COMPLIANCE TO THESE TERMS AND CONDITIONS
61. THE SITE ALSO RESERVE THE RIGHT TO CANCEL DUE TO LOW TURNOUT ON GAME DAYS ( PLEASE READ CANCELLATION POLICY EXPLANATION ) IF RESERVATION DEPOSITS HAVE ONLY BEEN PAID, PAYMENTS WILL NOT BE RETURNED FOR LOW TURN OUT. HOWEVER IF FULL PAYMENT HAS BEEN PAID THE SESSION WILL GO AHEAD.
